It's important to be aligned in that way and to have the plan inform the reorg.

**Answer:** By the next meeting, yes, we're going to go by the plan in terms of following up and starting these conversations. Part of that will be reorganizing the committee structure and seeing how we follow up with what we stated in the plan, going from start to finish.
